

HUGH GREEN 1931-2012

Hugh Green was born in Raphoe, County Donegal, Ireland and was one of eight siblings. They grew up with very little by today's standards.

Although Hugh left school at the age of twelve, he gained great knowledge and skills at the cattle sales with his father.

At the age of seventeen, Hugh left Ireland for Scotland and eventually made his way to New Zealand. Through unwavering determination and hard work, Hugh achieved substantial business

success in New Zealand and maintained a lifelong commitment to giving back to others; "One of the best things about having acquired some wealth through making good deals is that you can use it to provide help where it's needed."

After Hugh's passing in 2012, Hugh's eldest daughter Maryanne set up the Hugo Charitable Trust to continue his legacy of giving a hand up to those in need.

We are sure that Hugh would be proud to see the lasting impact of his hard work.

FROM MARK

Hugh Green finished his school days at the grand age of twelve when he left school to seek his fortune. He initially worked as a cattle drover in Donegal before heading to Scotland, where work was plentiful with the Scotland Hydroelectric Board on their "Power from the Glens" project after World War II.

Armed with a "few bob" in his pocket, he bought a ten-pound ticket to Australia, hoping to make enough money to return to Ireland and set himself up in the cattle business. A brief stopover in New Zealand changed everything when he met Moira, with whom he would settle and have his family.

With little formal education, it was no surprise that Hugh had limited reading and writing when he started his contracting business in Auckland with Barney McCahill. Competing for complex public works contracts, it didn't take long for Hugh to develop his reading skills to a high level, although he never really wrote a lot down. Many of his business colleagues told stories of Hugh getting the better of top legal minds with his ability to understand and interpret complex contracts to his advantage.

Perhaps his life journey was in the back of his mind when he said in his book "The Irish Immigrant that Never Left Home" that education "was the most important tool to escape poverty." This year, the Hugo Charitable Trust has donated to New Zealand schools to support improving literacy skills in young people. While we are very happy to help, I don't think Hugh Green would ever have imagined that literacy in New Zealand in 2023 would be in any way comparable to Donegal in the 1930s, yet here we are.

I hope you enjoy reading our 7th Annual Report and you enjoy the diversity of our donations. One of my favorites is Wish4Fish empowering people with all sorts of challenges to get out on the water and bag themselves a fish in their uniquely accessible boat.

Since our establishment in 2017, we have been able to grow our capital base to over \$82m while donating over \$16m to New Zealand charities. The Trustees are grateful to the Hugh Green Family Trust and Owens Properties Ltd, who have paid all our administration costs and allowed us to donate the total income from our investments to the charities we support.

Finally, thank you to our founder, Maryanne Green, who established the Hugo Charitable Trust in 2017 to continue the philanthropy of her father, Hugh Green. Thank you also to our CEO, Aoibheann Monaghan and the Trustees for another successful year of giving.

FROM AOIBHEANN

Céad míle fáilte, I hope you enjoy reading our 7th Annual Report since we established the Hugo Charitable Trust in 2017. So far, Hugo has donated over \$16 million to a wide range of charities, mainly within New Zealand but also to the Pacific Islands and to Hugh Green's home country, Ireland.

I've heard that Hugh often said, "One of the best things about having acquired some wealth is that you can use it to help people when it's needed." At Hugo, we believe in lending a hand up, not a handout, and so it always gives us immense pleasure to be able to assist people with disabilities.

This year, we were happy to support Catwalk founder Catriona Williams in bringing the first fully wheelchair-accessible campervan to New Zealand. We have also supported Wish4Fish, Tri Star D-Gym, MINT Wanaka, Altus Resource Trust, The Hearing House and many other charities helping people with disabilities. You can read more about these great charities later in the report.

On the business side, our founder, Maryanne Green, regularly reminds me that you can't give the money away unless you make it first. My aim for 2023 was to grow our capital base while maintaining a good level of giving. Higher interest rates on our deposits and the rental income from our property investments have allowed us to increase our capital base to over \$82 million while still making donations of over \$16 million. This growth in our capital will allow us to make even larger donations in the future as we are able to earn greater returns.

On a personal note, in June, I returned to my local parish in Ireland to marry my partner Sam at St Macartan's Church in Augher, County Tyrone. In



2020 Hugo donated a stained glass window for the church's renovation. I was very proud to be presented with a lovely painting at my wedding and to see the church win the Irish Church of the Year Heritage Award.

Lastly, I would like to thank our founder,
Maryanne, and the Trustees for their support and
guidance during the year. Thanks also to Daniel
Sweeney from Total Brand of Queenstown, who
has done a wonderful job compiling this report.
I hope you enjoy reading the many stories of the
true heroes who work under the radar and help
those most in need in New Zealand.

STATEMENT OF SERVICE PERFORMANCE OUR ORIGINS

Maryanne Green established the Hugo Charitable Trust in 2017 to continue the legacy of helping others started by her father, Hugh Green. Hugh Green's aim was to assist poor people in social and medical areas; to give back to the people of New Zealand but never forgetting where he came from.

Hugh Green, born in 1931 in County Donegal in Ireland, was the fifth of eight children. Hugh endured great hardship through his early life before moving to New Zealand as a young man where he worked hard and lived by strong Catholic values which he encouraged his children to follow.

As he went on to earn business successes, Hugh set about establishing a pattern of philanthropic giving to those less fortunate than himself.

Hugh's eldest daughter, Maryanne Green, established the Trust in his name to continue his generous giving and in his memory, along with Trustees; Mark Owens, Kathryn Roberts, Bruce Stewart and Aoibheann Monaghan.

Our capital base of over \$82 million is invested and managed prudently in order to produce the necessary funding for donations each year.

While we do not actively seek donations from the public, we have had some interest regarding donations to the Trust. We use any additional donations received to increase our impact via charitable giving.

 The support of charitable organisations that further the above purposes; and




j. Any other purposes within New Zealand which are charitable according to the law of New Zealand.










CAPITAL BASE INVESTMENTS



The original Hugo capital base of \$75 million is maintained and not used to cover operational costs or donations. The income from Hugo's investments is used to donate to charities throughout New Zealand.

Since our establishment in 2017, we have been able to grow our capital base to over \$82 million (an increase of \$7,765,595) while donating over \$16.7 million to New Zealand charities.

Have Wheels Will Travel



DONATION: \$100,000

(Story supplied)

What started out as the desire for one couple to go on a road trip a few years ago has transformed into something for everyone to enjoy.

Catriona Williams - former international equestrian and Founder of The CatWalk Spinal Cord Injury Research Trust ("CatWalk") - loves a challenge. But fundraising was never a challenge she thought would be a major part of her life. A fall from a horse in 2002 left her a C6-7 tetraplegic and her world of horse-riding, competing, and representing NZ internationally, came to an abrupt halt.

Catriona's friends wanted to raise money for her - to make her life easier, but all she hoped for was legs that worked again. As a result, in 2005, CatWalk was founded with the mission of funding research for a cure for spinal cord injury.

After over a decade of leading the fundraising charge at CatWalk, Catriona decided to take a backseat in fundraising, to concentrate on her physical recovery and progress - an exhausting daily challenge.

The time came to take a holiday with her husband Sam. The couple agreed to trip around New Zealand, taking in the sights of Aotearoa. They were however met with a stark reality - there are no accessible campers.

Not content to leave it at that, Catriona decided it was time to put her fundraising skills to the task again.

After much research on campervans, accessibility needs (for any disability), costs, and rental requirements; a few non-negotiables were decided on.

This camper:

- must accommodate a wheelchair up the front,
- have an accessible bathroom,
- give back to the community.

Thanks to the generous support of Sugar Design in Masterton, a strategy proposal titled "Have Wheels Will Travel" was drawn up, with the principal aim of sourcing the core funding of \$350,000-\$450,000 required to build an accessible campervan.

Major donations were received from four supporters; long-time friend and former Chairman of the Board of CatWalk, Scott Malcolm, and wife Jane Taylor (Sydney-based Kiwis); John Messara of Arrowfield Stud Australia, Debbie, Paul, Alinta, Talia and Lara Kepitis, and the Hugo Charitable Trust.

These core funders were fittingly named the "Awesome Foursome".

Alongside the Awesome Foursome, ACM Motorhomes owner Chris Cunard has donated \$50,000 of time and expertise, and two other funders have also contributed for incidentals - Rob and Jean Johnston, and Jonathan Munce.

An extra special charitable addition to this project means that the income generated by the camper, is divided three ways.

- 40% of rental fees will go to Milner Mobility a vehicle mobility centre in Auckland dedicated
 to finding the right vehicle to suit someone's
 disability needs. The Milner team are in charge
 of the hiring, website and management once
 it's up for rental.
- 30% of net proceeds will be donated to CatWalk
- 30% of net proceeds will be donated to The NZ Spinal Trust.

Have Wheels Will Travel is the gift that keeps giving.

This one-of-a-kind camper has been named 'Charly' after the 20-year-old, 2023 Wimbledon Champion, Carlos Alcaraz. Carlos - a variant of Charles - nickname Charly. Charly means "free

man" or "valiant." The freedom to do what you love, fight for what you believe, and be with the people that mean the most to you is such a vital thing.



DONATION: \$100,000

Hugo was delighted to contribute \$100,000 to The Hearing House, a charity that helps people who use cochlear implants to hear. The contribution will go towards funding a community hearing van in South Auckland, due to launch in 2024. The specially-adapted van will provide greater access to The Hearing House's services, including assessments, screenings and consultations with audiologists and speech and language therapists, in an effort to better serve communities and raise greater awareness of the benefits of cochlear implants.

The Hearing House currently conducts around 100 outreach clinics in the regions it serves each year, but is often restricted in its reach by lack of available outpatient space at hospitals and health clinics. It's hoped the visibility of the mobile clinic and its services will lead to improved services and better outcomes for clients.

They were very moved, and they are both very aware of the beautiful connection with your respective Fathers that this project entails. Thank you again – this means the world to us all."

Gratitude, thanks and happiness have been the committee's exclusive experience recently.

The Hugo Charitable Trust, based in Arrowtown and with no connection to our district have generously donated \$80,000 to our building project. We will be pleased to name the new nurses room after the Hugo Charitable Trust, our biggest donor.

The project goal became that much nearer with several other recent large donations and we thank the Maurice Carter Trust for \$50,000 (\$20,000 of which we receive in one year) and the Mauger Charitable Trust for \$25,000. We have received these generous grants because funders could see the high level of volunteer contributions to our project.

Our recent wedding dress exhibition was our recent example of massive, skillful, voluntary work that raised \$3,096 with the support of the Bay Harbour Church. There are barely enough words to show how grateful the committee is for this support.

You will have seen our thermometer raised to 80% and with the council having approved \$10,000 towards sustainable improvements to the 1991 building we can raise it slightly further.

That we have reached this near starting the build is an achievement the community can be proud of and a more definitive position should be available one month from now. Those intending to contribute, and doing so soon, are going to take us from 'we can do the build' to 'we are underway'. You are crucial.

Abilities Group, Auckland









DONATION: \$50,000

Abilities Group are a recycling charity with a heart for people with disabilities. Our aim is to enrich their lives by offering fulfilling work opportunities. We are a growing team with over 100 disabled staff who are assisted by 40+ support staff. The demand for recycling services across Auckland is increasing at pace and as one of only a handful of recyclers in the region, it's critical we meet this demand. Not only does this protect our environment but it also helps us continue to provide employment for disabled people who often find it difficult to find suitable roles in the open job market.

One of our limiting factors in meeting the increased demand was our fleet of delivery vehicles. Our trucks didn't have sufficient capacity and our oldest had nearly 700,000 km on the clock! The maintenance costs for this vehicle were starting to increase, creating overheads and risk for our team. With the generous support of the Hugo Charitable Trust

we were able to purchase a brand new vehicle. Our new truck is significantly bigger than our previous one meaning we have increased our capacity by 75%.

We can now pick up 14 pallets of recycling per trip resulting in fewer trips to the same location - this creates huge efficiencies. It is also a new modern vehicle so has fewer emissions not to mention being a breeze to drive, or so our truck driver tells us!

Ultimately, we are able to recycle more material in a shorter timeframe with our new vehicle. This means more work for our team and more job opportunities for our disabled community. It's hard to put into words how much a job at Abilities means to our team and their families. Having a safe, consistent place to work, where your needs are understood, you are taken care of and are contributing to something much bigger – it means the world. Our heartfelt thanks to the Hugo Charitable Trust for your ongoing support.

Child Cancer Foundation

DONATION: \$35,000

Child Cancer Foundation is a New Zealand charity that provides support to children and families on their cancer journey. We support them every step of the way, helping them to overcome challenges and maintain control of their lives.

We focus on the whānau, not the cancer. No two families' experiences are the same, and neither is the nature of the support they need. One thing is always the same: we support every family so they can concentrate on the most important thing of all, loving and caring for their child.

After 20 years in a building which is run down and no longer fit for purpose for staff or the families we support, Child Cancer Foundation is moving to a smaller open plan office space. Helping us with the infrastructure for the new office space and space for families, the Hugo Charitable Trust is ensuring; we continue to stay close to Starship, we continue to have a dedicated space





for children and their families, and all of our Auckland staff can co-locate in the same building on the same floor! The entire team is incredibly grateful to the Hugo Charitable Trust.

Our focus extends beyond end-of-life care; we strive to create an environment where individuals and their whānau have choices and quality of life for as long as possible. Whether facilitating access to medical services, supporting caregivers, offering a compassionate ear, or providing assistance through educational



workshops and support groups, our team is committed to walking alongside our patients and their families every step of the way.

Hugo is grateful to Oliver Lee for referring Tadhg Giles and his family to us.

Tadhg's Mum (Laura) is from Kilkee, Co. Clare, Ireland, and Dad (Greg) is from Dunedin and they have a daughter Teagan who is two-years-old.

In late September 2023, 10-year-old Tadhg caught a flu infection which turned into viral encephalitis (encephalopathy). As a result he has suffered severe brain damage which has left him non-verbal with memory loss, psychosis, catatonic episodes and an altered mental status.

Tadhg's Mum, Laura, provided a recent update:

"The transfer from Auckland to Christchurch on Wed 28th Feb was very difficult. Tadhg was incubated, on a ventilator and under general anaesthetic for the medical flight. He remained on the ventilator for 36 hours. When he came off it took him 10 hours to wake up.

Both Greg and I are caring for him in our Christchurch home now, but he always needs constant supervision and the support of two adults. We have support workers pretty much 24/7, and some hours are funded by Health New Zealand after we accepted a support package following 5 wholly inadequate proposals. We have significantly modified our home to allow for separate areas for Tadhg and our 2-year-old daughter Teagan, and a roster of friends are helping to care for Tadhg as well.

Tadhg is still significantly cognitively impaired, non-verbal, with no understanding of language or even simple instruction and is incontinent. However, since moving back to our home Tadhg has become less agitated, and this makes the day to day a little less challenging than it was in Auckland. We have taken Tadhg out to the park a few times for a kick and run around (and he loves this - loads of happy sounds) and he has had his first time in a car this weekend after 6 months, which went well and he smiled. Thanks again for the kind support from the Hugo Charitable Trust."

Wish4Fish, in collaboration with the Hugo Charitable Trust, is making a profound difference in our communities by empowering individuals facing physical disabilities or mental unwellness. By providing inclusive and memorable fishing experiences, Wish4Fish aims to enhance the overall wellbeing, confidence, and quality of life of those facing physical disabilities or mental unwellness.

The partnership between Wish4Fish and the Hugo Trust is enabling lasting positive change in the lives of individuals with disabilities or mental unwellness, enriching their lives through the therapeutic power of the ocean and the joys of fishing. Together, we are making a significant impact on the community, promoting empowerment, and providing transformative experiences that contribute to the physical and emotional well-being of those in need.

Waiheke Health Trust

Hugo donated \$11,500 to the Waiheke Health Trust for the purchase of the Kera sit2sit hoist and a Raizer Lifting Chair. The Raizer Lifting Chair is a mobile lifting chair that helps a fallen person up to almost standing within just a few minutes.

"The Kera sit2sit hoist is a new device that is making it simpler to assist a person who is elderly or disabled to transfer positions, such as from their wheelchair to bed. Existing options for moving someone who has limited mobility can be slow and cumbersome, often requiring two caregivers to operate. The innovative design of the Kera empowers a single caregiver, often a partner or family member, to effortlessly move a person to and from their wheelchair.

The Kera was invented in NZ by Professor Keith Alexander, who is known for inventing the Springfree trampoline. Further developed by CTO of HT Systems Dr Alex O'Keefe, whose sister



uses a wheelchair, the Kera is now changing the lives of people around the world by empowering those who have lost their mobility to regain their freedoms." Alex O'Keefe, CTO at HT Systems

Altus Resource Trust, Auckland

Altus Resource Trust works with organisations in the Pacific Islands who provide services for children and adults with disabilities. We have physiotherapists, occupational therapists, speech language therapists, wheelchair technicians and nurses involved in training field workers and health professionals in these organisations, when they don't have the skill base required to work effectively. We also



provide housing modifications such as accessible bathrooms, ramps and paths.

The Pacific Islands are neighbours of New Zealand and have close ties with our country. As the population in the Islands is low, specialist services such as therapists who work with people with disabilities are limited. Equipment such as complex wheelchairs and walkers are rarely available unless donated items have been provided by countries such as New Zealand and Australia.

Dance & Art Therapy NZ

Dance and Arts Therapy NZ (DTNZ) has been committed to being the nation's leading provider of dance and arts therapy for over 10 years. DTNZ's kaupapa is to support and empower people of all ages, and in all situations, including those living with disabilities, mental health challenges, tamariki from low-income whānau and survivors of trauma in Tāmaki Makaurau, the Waikato, Whanganui, Wellington, Christchurch and Dunedin.

In the last year DTNZ supported over 3,000 individuals at dance and art therapy sessions around Aotearoa to increase wellbeing, decrease isolation, and provide mental health support. Isla Goodwin, Taranaki

Following a referral from Greg Dunlop, the Hugo Charitable Trust was pleased to make a donation of \$5,000 to 3-year-old Isla Goodwin from Taranaki.

Isla was born with Down Syndrome, micro-deletion of her 15th Chromosome (another genetic condition), AVSD heart defect (multiple holes in her heart), kidney reflux causing recurrent urine infections and requiring surgery and feeding difficulties due to low muscle tone and heart defect.

Due to her medical diagnosis, she has a developmental delay and low tone, which means she has to work harder to achieve her milestones.

The first 11 months of her life she struggled due to her heart condition and went into heart failure at about 8 weeks old. Isla has had 7 surgeries at Starship since birth and countless appointments with doctors and specialists.

Isla's family has managed to get Isla enrolled in a fantastic course in Australia called NAPA. Isla will have access to a combination of occupational



therapy, physiotherapy and speech and language therapy. We wish Isla and her family all the best of luck!

Tri Star Gymnastics, Auckland

Tri Star Gymnastics is based in Mt Roskill, Auckland and is known in gymnastics circles for producing Commonwealth and Olympic athletes, but they also have a large recreational membership. Children of all abilities access their classes and 6 years ago the club identified that some children required a more tailored programme to meet their higher needs. This saw the birth of Tri Stars Diverse-ability Gymnastics Programme (D-Gym). Tri Star now offers private classes as well as small group sessions to more than 60 children with physical or intellectual disabilities every week. The D-Gym programme offers a safe yet challenging sporting opportunity, where access to mainstream sports is often not possible. A gymnastics facility is like a big playground; with all the soft mats, bars, swinging rings, foam pit and trampolines; and these training tools provide a stimulating

and exciting exercise environment for D-Gym children. Additionally Tri Star offer D-Gym families holiday programme classes (to give mum and dad a break), and open days where all the families come together to celebrate their children and share their experiences.

To keep fees accessible Tri Star relies on fundraising to help cover programme costs. In 2023 Tri Star lost one of its key funding partners and it was a chance encounter between David Phillips (Tri Star General Manager) and Maryanne Owens (Hugo Founder); both out for a walk around Lake Hayes in Queenstown, that connected Hugo to this awesome programme. You never know who you are going to meet when you are out for a walk! Hugo's contribution directly supports staffing costs. This enables Tri Star to keep fees for their DGym programme accessible to as many families as possible. Thanks Hugo!

Arrowtown Community Centre

Nicolet Spice from Arrowtown Community
Response Group (ACRG), first approached the

a defibrillator at the Arrowtown Community
Centre. ACRG is a charitable volunteer
organisation advocating for the interests and
betterment of Arrowtown and its surroundings.

ACRG has been formed as a first-response team able to operate in the case of a major catastrophic event. The potential users of the AED include:

- First Responders in the event of a catastrophe
- Rugby players/referees during games/practice



- Scouts and leaders during the weekly meetings
- Community groups that use the clubrooms during the day – yoga, board meetings, dance groups, weddings etc.
- Nearby residents
- Children using the Jack Reid Park playground.

Portia Rose Swan, Auckland

On 30 Sept 2022, Portia Rose Swan (14-years) underwent brain surgery to remove a grade 3 Astrocytoma tumour.

While delighted that Portia (pictured right) pulled through, parents Matt & Penny and the entire Swan family were devastated to learn that 20% of the tumour remained, being too risky to remove at the time. A second operation was now urgent, with the remaining tumour located in a very high-risk area of Portia's brain, which could grow and become inoperable if left any longer.

Portia underwent an 'Awake Craniotomy' on 21 November in Auckland. The surgery was performed while she was conscious and able to talk to her surgeons, to reduce the risk of damaging critical areas of her brain which control speech and movement.

Portia's journey will continue to be long and tough but the Swans are facing it with strength



and positivity and will do whatever it takes to give their darling Portia a bright future. Portia has shown incredible resilience and bravery beyond measure over the past year.

The original mission of Hugh Green to 'assist poor people in social and medical areas; to give back to the people of NZ but never forgetting where he came from' lies very close to Dilworth's and the school is incredibly grateful that Maryanne Green has been honouring and carrying on her father's mission at the Hugo Charitable Trust. It is wonderful when charitable missions align and in this case, both charities feel thrilled that this grant from HCT fulfils both their philanthropic ambitions.

Matthew has had an interesting start to his life. He was born in Muscat, Oman to Egyptian parents who are active in the Coptic Christian Church. Like many other Copts, Matthew's parents left Egypt due to religious persecution. They made their way to Canada before arriving in New Zealand in 2010.

Matthew is a standout performer at his studies, no matter what they are. He is currently working towards his International Baccalaureate
Diploma and has also completed several Level

2 mathematics standards, achieving Excellence and Merit grades. He constantly does extra self-directed studies in his school subjects and can relate those subjects back to the inequalities and troubles of the wider world. Furthermore, Matthew is a keen football player and is part of the school's first XI. He also participates in the following community commitments: - Amnesty International Youth Group, Red Cross, SADD, UNESCO, UNICEF and leads the Physics Pathfinders initiative. He has recently been selected to become a school Prefect.

Matthew has lived and breathed aviation since he was a 3-year-old child. He has been accepted into the North Shore Young Eagles programme and has since won the "Top Gun" award. He enjoys writing aviation articles for the North Shore Aero Club's magazine and also for the nationwide publication – KiwiFlyer.

He is a member of 5 Squadron Air Training Corps, which affords him the opportunity to participate in ANZAC services, complete community service, and study aviation theory. He also enjoys meet ups with plane spotters to socialize and converse over their common passion.

"Our Little Explorers group alone has supported young parents to provide experiences for their tamariki that were previously out of reach. Trips to Orana Park, Turanga, QEII Taiora is facilitating bonding and connection as well as building memories for life."

In 1987 they gifted Mary Potter Hospice to the people of Wellington by establishing a charitable trust.

The Mary Potter Hospice Foundation was delighted to receive the news that the Hugo Charitable Trust has donated \$44,000 to enable us to purchase a cargo van for use in our retail operations.



We provide specialist palliative care services for people living in Wellington, Porirua and Kāpiti. Our services are totally free-of-charge, and we work primarily with patients, families and carers in the place they call home, and at our Inpatient Unit in Newtown, Wellington.

Mary Potter Hospice has eight second-hand retail stores across Wellington, Porirua and Kāpiti, with all proceeds going directly towards helping us maintain our services free to the community. The shops are a vital contributor to our overall fundraising target, raising \$3,000,000 in the last financial year. Without support from Trusts and Foundations like the Hugo Charitable Trust, we wouldn't be able to maintain the level of care that we currently do.


We were met by our hosts for the day and it was great to hear Kiwi voices again. We divided into three groups after being given a quick introduction to the restoration of the building.



Live Ocean







DONATION: \$100,000

The ocean is our greatest ally in the fight for a healthy planet, but beneath its surface – the ocean and the life in it are in crisis. Climate change, pollution, and over-fishing are pushing it past its ability to cope.

Here in Aotearoa New Zealand, we are ocean giants. Settled first by waka then by ship, we are guardians to one of the largest and most significant ocean spaces on the planet. What we do here matters.

Founded by sailors Peter Burling and Blair Tuke, Live Ocean Foundation supports the work of exceptional New Zealand scientists, innovators and communicators to scale up action for a healthy ocean.

It's possible the ocean's kelp forests have unrealized potential which could prove hugely valuable in the global push to reduce carbon in the earth's atmosphere, but there's a piece of the kelp puzzle that needs solving.

With the help of the Hugo Charitable Trust, Live Ocean can support the work of Dr. Caitlin Blain from the University of Auckland to investigate how kelp forests contribute to coastal carbon cycles. Researchers know the majority of the carbon fixed by kelp through photosynthesis is being released back into the ocean, but what happens to it after that? This research will help scientists understand the long-term fate of this released carbon and the role of kelp forests in carbon sequestration.

Recreational Backcountry Pilots Association & Hollyford Conservation Trust







DONATION: \$30,000

In 2023 The Recreational Backcountry Pilots Association (RBPA) was approached by The Hollyford Conservation Trust (HCT) with a view to partnering in a project to help protect our native and endangered whio (Blue Duck).

The project area is a portion of the Kaipo River, which is a known habitat of the whio, and lies in the Kaipo Valley between the Hollyford Valley and Milford Sound. The area is almost inaccessible except by air. The area is an extension of the "mainland island" sanctuary that has already been achieved by the efforts of the HCT and the Big Bay Awarua Conservation Trust over the last

nine years. The existing area already covers in excess of 12,000 protected hectares.

Our project aims to protect the whio along a stretch of the river by placing trap lines on either side. We will then regularly check, clean and rebait the traps and report each predator that is trapped. Over the longer term one of the aims is to see more native birds that once inhabited the area being reintroduced, including kiwi. This is a very exciting conservation project.

We are very grateful and humbled by the generous donation from the Hugo Charitable Trust that will allow us to get the project underway. Thank You Hugo!

Whakatipu Rowing Club



DONATION: \$100,000

Whakatipu Rowing Club has been facilitating the opportunity to learn lifelong skills from rowing in an exceptional setting for Queenstown locals since 1958.

Originally located in the Bath House on Queenstown Bay, the club has managed very well to build its membership and equipment inventory, and provide a successful program without dedicated clubhouse facilities. Their current building is a boat storage shed at beautiful Lake Hayes. From here, the club have run a very successful program, achieving many national titles in school and masters rowing and in building a community of committed volunteers that ensure the club's continued success.

Emma Schmitz, a rower and architectural designer, has designed new facilities for the club that will greatly enhance their ability to make available an outdoor activity that builds confidence, character and intergenerational friendships. The new clubrooms, a second storey to existing boat storage, will house a meeting room, kitchen and bathroom, greatly improving accessibility and attracting new events and coaches. Whakatipu Rowing Club

also plan to make their new facility available to other community groups, thereby strengthening connections in the area and providing a meeting space matches the outstanding natural beauty of the area.

The Rowing Club approached the Hugo Trust for assistance with fundraising for the project. Maryanne and Aoibheann could see the potential community benefit and supported a very significant donation of \$100,000 for the club. As a result, the new upstairs area of the clubrooms will be known as The Hugo Room in perpetuity.

Hugo's donation is an enormous boost for the club. As the first funder to come onboard with the project, the Hugo Trust have provided a great deal of confidence and motivation to the volunteers driving the build and demonstrated a commitment to youth development in their local area.

Since Hugo's donation was made, spirits at the club are sky high and everyone is working together to move the project further toward completion. The club is very much looking forward to hosting the Hugo Trust in the new facility and showing the positive impact the donation will have on local rowers.

Alexandra Volunteer Fire Brigade

DONATION: \$10,000

Hugo donated \$10,000 to the Alexandra Volunteer Fire Brigade for the AF8 (Alpine Fault magnitude 8) programme, which focuses on earthquake preparation. AF8 aims to share Alpine Fault hazard and impact science and preparedness information widely, through communication and engagement activities, to increase awareness, enable conversation and build societal preparedness to natural hazard events in the South Island.

Communication links would be destroyed and coordination between emergency services would



be impossible if a serious Alpine Fault earthquake occurred. The donation will go towards a Starlink which is a space-based stand-alone system to allow internet access and mobile phone coverage.

Arrowtown Volunteer Fire Brigade

DONATION: \$4,600

The Hugo Charitable Trust has made a \$4,600 donation to the Arrowtown Volunteer Fire Brigade for a wheel system for their stretcher. This will provide easier carrying options, reducing fatigue and the chance of injury. It also allows the team to navigate the roughest terrain and slopes. In the previous financial year Hugo made a \$20,000 donation to their new first response vehicle.

Arrowtown Volunteer Fire Brigade Trust senior firefighter Kelvin Perriman says "since the brigade's 17-year-old response vehicle was identified as being in dire need of replacement, Arrowtown businesses and locals have swung in big behind the project, as too have the Central

Lakes Trust and Community Trust Southland."

The combined efforts raised the \$150,000 needed for the vehicle and medical first response gear. The 25-member voluntary brigade has already attended 170 calls so far this year, towards a likely total of 210-plus for the year. That compares to 140 in total last year.

"The need for this new technology and vehicle is quite crucial for a brigade like us," he says. "It's certainly not going to be sitting gathering dust."

Fellow senior firefighter Todd Weeks says with Arrowtown 15 minutes from the nearest ambulance station, the brigade's often the "first responders on medical callouts to people in dire need."

Search and Rescue Avalanche Dogs







DONATION: \$13,000

Hugo Charitable Trust have supported Search and Rescue Avalanche Dogs by donating four avalanche air bag back packs and three radios.

These items were deployed in an emergency event last winter at the Remarkables when a skier was caught in an avalanche.

Radios were used by emergency services, coordinated by the team on the ground and involving the Police, Search and Rescue

Avalanche Dogs and Remarkables ski area management and patrol. It is essential our team are all equipped with radios that can communicate with all other emergency service teams.

The danger of a further avalanche whilst searching was mitigated by the use of search dogs, who can clear a search area 20 times faster than a human team. To keep our handlers safe in the event of further avalanches, air bag back packs are essential. Thank you to Hugo Charitable Trust for their generous donation.

Mangere Budgeting Services Trust, based in South Auckland, has proven to be invaluable, particularly in supporting their food bank operations which always has a huge demand for food parcels throughout the year. Update: Living Options, Arrowtown

Living Options now has a residential house on the same street in Arrowtown as the new Living Options centre. This home is owned by a local family who have a son attending Living Options. The residential house allows Living Options to offer supported living next door to their centre – the model they already have in place in Alexandra where they support 23 people living in residential homes.

They are supporting 11 people in the Wakatipu community and 2 people living in the residential house in Arrowtown. The Arrowtown centre operates within the constraints of its resource consent allowing a maximum occupancy of five individuals along with their support staff at any given time.

Currently their focus lies predominantly on school leavers and people residing independently within the community.

Living Options do not have a waiting list. Once they receive a referral, they immediately initiate the process of offering essential support to the referred individual.

"While government funding covers personal care and household management for those we support, there is no provision for recreational activities. The support from The Hugo Trust has been instrumental in filling this gap and enriching the lives of those we support."

Update: Māpura Studios, Auckland

With your help, Mapura Studios is flourishing. We are now reaching around 420 disabled and marginalised people throughout the Auckland region, with 44 creative programmes of different genre - visual art, music, dance, movement, singing, written word and cartooning.

Creative programmes are now held in Orewa, Takapuna, Avondale, Mt Albert, St Lukes, Onehunga, Otahuhu, Penrose, Mangere, Otara, Manurewa, Papakura and Paremoremo.

Māpura works with a very vulnerable community who are still experiencing anxiety and isolation which has been exacerbated by the pandemic and more recently by the weather events experienced in Auckland. It is a time when many of our marginalised people need support, a sense of

belonging and inclusion. We have been reaching out with significant success to some of these people and bringing them into our inclusive and welcoming community.

Our art therapy programmes for young people on the autism spectrum are filling a real need as is our art tutor working in Central Auckland Special Schools amongst very high needs children. We'll be resuming working with maximum security inmates at Auckland Men's Prison shortly as well as working alongside a group of marginalised people at Mangere making murals on panels to be placed alongside a regenerative streams project which is beginning to happen locally.

Māpura is ever changing and adapting, thank you again to the Hugo Charitable Trust.

Update: Gillies McIndoe Research Institute (Story supplied)

When Jonathan Densem was diagnosed with an inoperable brain tumour he made a goal to record his own album. Seven years later, against the odds, the Canterbury musician is thriving and preparing to record his second album.

Densem has kept a positive attitude over the years, but his cancer has not come without its challenges for him and his family. The impact on the family, particularly his two sons Otto, 14 and Casper, 17, has been "traumatic."

The tumour, in the frontal lobe, can impact Densem's behaviour and ability to deal with stress. "I became incredibly short-tempered and wouldn't realise I was being rude and mean as I had this thing in my head," Densem said.

The financial cost, with Densem unable to work full-time has also caused a lot of stress. "The trauma of the financial cost has also been horrendous, as well as my inability to look after the rural property where we lived, so we had to sell. "I always feel tired and just don't get through

the things I think I am going to get through. All of this has had a catastrophic impact on the family."

In early 2016, Densem was diagnosed with glioblastoma multiforme, a fast-growing and aggressive brain tumour, but more recently he was re-diagnosed with anaplastic oligodendroglioma, still an incurable tumour, but one that is currently dormant. "I'm told it'll probably flare up again when I least expect it to," he said.

In 2017, Densem joined a clinical trial for glioblastoma by Gillies McIndoe Research Institute. He was a part of Phase I of the trial and took a combination of repurposed drugs, which are off-patent, common and safe medications.

Still on the drug regime, Densem believes it has made an "enormous" difference. "The idea is that if you can keep the cancer cells from replicating, you may not kill them, but at least you can prevent the tumour itself from growing. The goal is to die with cancer, not from cancer. With brain cancer the tumour will alter a function of the body that part of the brain controls. If you can stop it growing then you can live with it."



He is confident the drug regime is the main reason he is still fighting and feeling better than he did five years ago, but he accepts that this can not be proven at the moment.

More research is needed into the regime effectiveness and so later this year Gillies McIndoe Research Institute will begin its Phase II Clinical Trial into glioblastoma. This trial will be larger and start earlier in the treatment process, at the same time as the traditional approaches of surgery, radiotherapy and chemotherapy.

Densem and his family now live in Rangiora. He works two days a week teaching music and is looking to extend to three.

This week he will use his musical talents to support a fundraising campaign by Gillies McIndoe to raise funds for the Phase II trial, which is expected to cost \$3.6m. He will be performing two songs at a gala dinner in Wellington on Thursday, a love song he wrote for his wife Emma and a song about a girl who has cancer.

In 2017, he released his album 'I'm Saying It Now'. This goal was important for Densem as his father, a songwriter and jazz pianist, never got the chance to properly record his music. "My father was a great musician, but he died of a heart attack at 47 having never had his amazing songs professionally recorded. I had a big fear that if I had had a quick exit all of my songs would suffer the same fate."

He is now preparing to record a new album of just piano and vocals called Me and My Piano.

Having had time to reflect, Densem had some advice for those given a similar terminal diagnosis. He said it was important to protect your children's childhood by letting them know only what they need to know, so they can still enjoy life.

Having a positive attitude helps, as well as eating and exercising well. "Make sure everyone's underlying subconscious attitude is that we are outliers and not a statistic." Densem said.

HUGO TRUST'S \$17M-PLUS PROPERTY PLAY

In a big case of spending money to make money, Queenstown-based Hugo Charitable Trust has splashed \$17.6 million on two local commercial properties.

The national charity — which has donated \$15m-plus to various charitable causes over the past seven years — bought Bayleys House, in 2019, for \$10.15m, and last December, the New Zealand Couriers building, also in Frankton, for \$7.45m.

But, rather than using the buildings' rental income to pay back the purchases, Hugo puts it all back into its large charity pot.

In the case of Bayleys House, that's currently \$461,145 a year, and for the NZ Couriers building it's \$328,440 per year.

As a bonus, last year two Bayleys House tenants — realtor Bayleys and law firm Cruickshank Pryde — each donated \$10,000 to Hugo for proposed charities.

Hugo chair and trustee Mark Owens says the investment properties are a way of diversifying the charity's income.

"We didn't want it all in the bank or all in equities.

"It's really just risk management, so we've always got that rental income coming off those two buildings, and then we can donate it.

"We've got overall plans to have a third in property, a third in equities and a third in cash deposits."

Owens says they're keeping an eye out for a third property in a similar price bracket to the other two.

"We like something reasonably new — we want to be pretty passive, we don't want to be active property managers, as such."

He says they've so far chosen Queenstown properties partly due to their likely capital appreciation — "we think [Queenstown's] capital growth's going to be as good as anywhere in NZ" — and partly because he and the charity are based here.

"We live down here so it's a bit easier to manage ... it's nice just having it in the area you know."

TRUST, TRADIES PUTTING THEIR OAR IN

Thanks to generous business support, Whakatipu Rowing Club has four new boatsheds by its Lake Hayes club building.

The sheds were officially opened by long-time club patron Jim Boult at the club's open day last Sunday. He thanked Hamish Noton, of Form Construction, Paul and Peter Rogers, of RBJ, and architect Emma Schmitz for being "the drivers" of the project, along with suppliers including ITM Southern Lakes.

Club president Amy Wilson-White says all the labour and about 90% of the materials were donated for the \$300,000-plus project. "It frees up space for some of our boats and it will also increase the longevity of our coach boats 'cos at the moment they're sitting in water all winter."

Meanwhile, Hugo Charitable Trust - whose founding couple Maryanne Green and Mark Owens live locally - advised last Friday they're making the first major donation, of \$100,000,



towards the club building redevelopment project which will cost about \$1 million.

Subject to funding, and building consent, the project - extending the ground floor and adding a first floor with a main clubroom area - will start April 1 next year, after the rowing season's finished.

HUGO'S HEARTFELT GESTURE

A life-saving heart defibrillator has been donated to the Arrowtown Community Centre by local-based Hugo Charitable Trust.

The idea came from Arrowtown
Community Response Group member Nicolet
Spice. In conversation with Hugo trust founder
Maryanne Green and her husband, trust chair
Mark Owens, she told them the council-owned
centre would be the coordination centre in the
event of a local emergency. But, from doing a
check-list, she'd realised the centre didn't have a
defibrillator.

In a heart beat, Green and Owens, whose trust already donated to Spice's group, agreed to donate one. The \$6000 defib has subsequently been attached to an outside wall so the public can access it. It's linked to the internet, for status reporting, and is in a heated, frost-protected container.



Spice says it's handily placed as the centre and adjacent Jack Reid Park are used by the Arrowtown Rugby Club and other community groups, while it could also be useful for nearby residents. There's also a nice link for Green and Owens given their grandson Lorenzo Chambers plays for the Arrowtown Premiers rugby side.

NZ'S FIRST RENTAL MOTORHOME BUILT FOR WHEELCHAIR USERS SET

TO HIT THE ROAD

Catriona Williams has been a wheelchair user for more than two decades. For the last few years, she's been wanting to go on an adventure across New Zealand.

"I was chatting to Sam, my husband, and I said, why don't we do a roadie? We've got lots of friends all over the country" she said. "We went online and realised we couldn't hire an accessible motorhome."

So she made it her mission to get one built. To Williams, accessible means being able to get in – and out – herself, and drive or ride up the front. She said surfaces also need to be at the correct height.

"We don't want to just come and exist - we want to come and be part of the holiday."

Williams used her love of cooking to help raise more than \$400,000 through donations from Greenstone Partners, Sitipek, the Hugo Charitable Trust, and another anonymous donor, so ACM Motorhomes could design and build the perfect vehicle.

"It was full custom from the chassis up," designer and builder Chris Cunard said. "Every single piece of it was handmade."

It'll cost up to \$425 a day to rent from Milner Mobility, which specialises in wheelchair accessible vehicles.

"We always get enquiries around a rental motorhome," general manager Darren Milner said. "Since we've presented this on our website, the enquiries have just been huge both internationally and locally."



Around 60% of the rental fee will go towards Catwalk, a spinal cord research trust founded by Williams, and the New Zealand Spinal Trust.

Spinal Trust CEO Hans Wouters said it's the first "fully accessible motorhome that can be rented" in the country.

"For a family to take their loved one out who may have a spinal cord impairment and use a wheelchair and ordinarily would not have that opportunity, that's absolutely massive," he said.

Williams already has her first stop in mind.

"For me, I really want to go to the South Island – got lots of lovely friends down there. Nelson, Marlborough, Motueka – that's where I want to go," she said.

She'll be one of the first to rent the motorhome when it's ready for hire.

Māngere College wants to express its deep gratitude to the Hugo Charitable Trust for the generous donation of \$50,000 at the end of 2023 which, together with a school contribution, has allowed our school to purchase two new LDV vans.

"They give us far greater access to opportunities outside the school such as sports games and tournaments, educational trips, career and pathways development programmes, performing arts activities and cultural activities. They have already been used by staff around the school and our students have benefitted already with our 275 Rangatahi Xplorers trip to Rotorua and our Gateway to the World careers experiences."



Antonio, who was a Student Leader in 2023, says the vans not only open up new opportunities but look good too. "The vans are spacious and it is nice to know that we can just get in them and go to cool places which help us learn about our topics."

While Dorian, another 2023 Student Leader, says the hurdle of needing to rent expensive buses is no longer an issue. "What I like the most about the new vans is that we can do things like UE Camp and school outings for cheaper. When thinking about this in our sustainability class, it is economically and socially positive for our school as it saves us money, and also improves learning opportunities."

And Mikayle, Mangere College's 2023 Head Student, says the school is hugely grateful to the Hugo Charitable Trust. "Thank you to Hugo Charitable Trust for investing in our school and our students' future. At this UE camp we have had the opportunity to gain the best University Entrance results for our school and this was only possible because barriers to transport were reduced."

Ireland Update: Raphoe Tidy Towns



The town of Raphoe in County Donegal Ireland, the birthplace of Hugh Green, continues to benefit from the Hugo Charitable Trust Gift.

In November 2018 the Hugh Trust gifted €100,000 to assist with Raphoe's status as a Heritage Town of Donegal. Many of the projects had to be stalled because of Covid-19 lockdowns but almost all have now been completed.

This year the town centre, the Diamond, was given a facelift when all the listed buildings and Georgian doors were repainted in heritage colours. The Diamond is where the Fair Days were held and it's where Hugh Green, in his own words, "made my first shilling" as a cattle drover. He was just 12 years of age.

The project included the painting of an iconic mural depicting a Fair Day in the Diamond inspired by Hugh Green's story and copied from a photograph taken in the early 1950s. Mural artist, Nik Purdy from Sligo, was commissioned to reproduce the image onto a gable wall with the kind permission of the Hyndman family.

Mary Harte, Chair of Raphoe Community In Action said the mural "is like looking into a mirror of the past with the living scene just over your shoulder." She added that the Hugo Charitable Trust has been invaluable to breathing new life into the town with many visitors now coming to look at the mural and the lovely buildings in the centre, "Hugh would have been immensely proud of what we have achieved."

The Hugo Charitable Trust partnered with Donegal County Council in the Town and Village Renewal Programme which was co-funded by the Irish government Heritage Department. Another project in the programme was the creation of a Heritage and Tourism Hub in the Volt House, the community resource centre and to where Hugh often called for a chat about old times.

The Raphoe Tidy Towns group presented a portrait of Hugh to the Volt House as an appreciation of the friendship shown by the Hugo Charitable Trust to his hometown. The portrait was drawn in pencil by a young local artist Eleanor Duffy whose grandfather, Eddie Duffy, was a school friend of Hugh.

When the Board of Hugo visited Raphoe in 2018, Chairman Mark Owens said that Raphoe's image as an old Market Town with its Fair Day in the Diamond and the 19th century architecture gave it an edge that other towns no longer had. "I'm from New Zealand and I love the sense of history and charm that Raphoe exudes."

The community of Raphoe is extremely grateful to the Hugo Charitable Trust for ensuring that charm and history of Raphoe is appreciated and enjoyed. Mary Harte said the final project will be the establishment of a summer music school to teach wind instruments to young people in the area. "Also an important part of our cultural heritage" she added.





Ireland Update: John C. McGee Book Collection

We had a wonderful event on Saturday12th of August 2023. It was the first day of National Heritage Week and we opened the John C. Mc Gee Book Collection to the public.

The collection looks great behind the glass door shelves in their renovated room that was generously funded by The Hugo Charitable Trust.

The five thousand book collection assembled in Philadelphia, U.S.A. during 1970s and 1980s is now catalogued according to book title, author and according to book block and shelf.

It is proving to be of great interest to the older generation who knew the compiler of the collection especially those who knew him in U.S.A. when he was working on his collection. This was an aspect of the launch that we hadn't anticipated. Our day began on Saturday last August 12th with a talk on John C. Mc Gee - Book Collector. The talk focused on the book collector as preserver of cultural heritage. The second part of the talk focused on John C. Mc Gee's life story, and his collecting and interaction with other collectors here in Ireland.

The next part of the talk dealt with the themes covered by the book collection itself, Irish History and Irish literature. The collection covers novels, dramas and poetry in Irish and in English with a particular emphasis on Donegal Authors. Other topics covered included music and the other minority languages of Scots Gaelic and Welsh.

The final part of the talk dealt with the conservation work carried out on the books since the Éigse Sheagháin Bháin Committee bought the books from the late John C. Mc Gee. During this part tribute was paid to Maryanne and everyone at The Hugo Charitable Trust for the generous support we received to bring this valuable jewel and educational resource into the public domain. After the talk refreshments were served and the John C. Mc Gee Room was open for viewing. The room was open each afternoon 13th - 20th August 2023 from 1.00pm till 4.00pm. This coincided with the duration of National Heritage Week.

The Collection will continue to be open in the coming months and years. We are more than happy with the way the venue and book collection turned out.

The Collection will be available for those who want to continue their research on Irish History and literature and more particularly County Donegal related matters. We enclose photographs of our Heritage Week Event featuring the opening of the John C. Mc Gee Collection and the display cabinets supported by The Hugo Charitable Trust.

We hope that we will be able to welcome any of you that are visiting in this area in the future and be able to give you a tour of the Mc Gee library. With every good wish for the future.



Nature of Entity: Charitable Trust

Purpose:

Maryanne Green as the Settlor, established the Hugo Charitable Trust ("Hugo") to continue the legacy of helping others started by her father, Hugh Green.

Hugh Green, born in 1931 in County Donegal in Ireland, was the fifth of eight children. Hugh endured great hardship through his early life before moving to New Zealand as a young man, where he worked hard and lived by strong Catholic values, which he encouraged his children to follow. As he went on to earn business success, he set about establishing a pattern of philanthropic giving to those less fortunate than himself. Hugh's eldest daughter, Maryanne Green, established this Trust in his name to continue his generous giving and in his memory.

Notes to the Consolidated Financial Statements

General Overview 1.

Reporting Entity

Hugo Charitable Trust is established and domiciled in New Zealand and is a registered charity under the Charities Act 2005.

The purpose of Hugo is to continue the legacy of helping others started by Hugh Green.

The consolidated financial statements presented are for Hugo Charitable Trust and its subsidiaries; Hugo Charitable Trust Limited and Hugo Limited ("the Group") as at and for the year ended 31 March 2024. The Group financial statements comprise the Trust and its controlled entities. The consolidated financial statements were authorised for issue by the Trustees.

Basis of Preparation

The consolidated financial statements have been prepared in accordance with New Zealand Generally Accepted Accounting Practice ("NZ GAAP"). They comply with the Public Benefit Entity Standards Reduced Disclosure Regime ("PBE Standards RDR") as appropriate for Tier 2 not-forprofit public benefit entities, and disclosure concessions have been applied. As a registered charity, the Group is required to prepare financial statements in accordance with NZ GAAP as specified in XRB A1.

The Group has elected to report in accordance with PBE Accounting Standards Not-For-Profit Tier 2 on the basis that it does not have public accountability and has total annual expenses of less than \$33 million in the current and prior year.

The consolidated financial statements are presented rounded to the nearest New Zealand dollar (NZ\$), which is the Group's functional currency and have been prepared on an accrual and historical cost basis.

The Consolidated Statement of Cash Flows has been prepared using the direct method.

The Consolidated Statement of Financial Position has been presented in order of liquidity as the Trustees judge this provides the most relevant and reliable information to the users of the consolidated financial statements.

The consolidated financial statements were authorised for issue by the Trustees on 3 May 2024.

c Basis of Consolidation

A listing of the Group's significant controlled entities is presented below:

All controlled entities have the same reporting date as the controlling entity.

There are no significant restrictions regarding to the transfer of dividends, loan repayments, and other funds from controlled entities.

There are no significant restrictions on Hugo Charitable Trust's ability to access or use assets, and settle liabilities, of the group's controlled entities.

Use of Estimates and Judgements

The preparation of the consolidated financial statements in conformity with PBE Standards RDR requires management to make judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, income and expenses. Actual results may differ from those estimates.

There are no significant estimates used in the preparation of the consolidated financial statements other than the determination of the fair value of the investment property. Refer to Note 8 that outlines the key estimates and judgements made in relation to fair value of the investment property.

d Taxes

All entities in the Group are registered charities under the Charities Act 2005 and have an income tax exemption on the grounds of charitable purpose under Section CW41 of the Income Tax Act 2007. Hugo Charitable Trust and Hugo Limited are not registered for GST purposes. Hugo Charitable Trust Limited is registered for GST. The consolidated financial statements are prepared on a GST inclusive basis except for revenue and expense transactions relating to Hugo Charitable Trust Limited. These transactions are stated on a GST exclusive basis.

e Cash and Cash Equivalents

Cash and cash equivalents comprise of cash at bank with a maturity date at less than 90 days and in the prior year, cash held in investment portfolios.

f Receivables and Prepayments

Receivables comprise of accrued interest on term deposits and bank accounts, prepayments and other investment property receivables.

g Payables and Income Received in Advance

Payables comprise of trade payables, GST payable and income received in advance.

h Revenue

Revenue from exchange transactions

i Rental income

> Rental income from investment property is recognised in surplus or deficit on a straightline basis over the term of the lease. Lease incentives granted are recognised as an integral part of the total rental income, over the term of the lease.

Revenue from non-exchange transactions

i Distributions received

> Distributions received are recognised on receipt or when the economic flow can be reliably estimated as revenue in the Consolidated Statement of Comprehensive Revenue and Expense.

ii Donations received

> Donations received are recognised on receipt in the Consolidated Statement of Comprehensive Revenue and Expense.

Non-exchange transactions are those where the Group receives an inflow of resources (i.e. cash and other tangible or intangible items) but provides no (or nominal) direct consideration in return.

The Inflows of resources from non-exchange transactions are only recognised as assets where both it is probable that the associated future economic benefit or service potential will flow to the entity, and fair value is reliably measurable.

Other income

i Interest income

Interest income is earned on term investments and bank accounts.

i Interest income (continued)

> Interest income is recognised net of withholding tax in the Consolidated Statement of Comprehensive Revenue and Expense as it is earned. Interest income is accrued using the effective interest rate method. The effective interest rate exactly discounts estimated future cash receipts through the expected life of the financial asset to that asset's net carrying amount. The method applies this rate to the principal outstanding to determine interest revenue each period.

ii Dividends and PIE Income received

> Dividend income is recognised in the Consolidated Statement of Comprehensive Revenue and Expense when the Group's right to receive payment is established, and the amount can be reliably measured. Dividend income is recognised net of any imputation credits and dividend withholding tax.

i Foreign exchange gain or losses

Foreign exchange gain or losses are recognised on portfolio investments when:

- A) foreign bank accounts are revalued; and
- B) when share, currency or bond trades occur in a currency other than New Zealand Dollars.

The foreign exchange gain or loss is recognised in the Consolidated Statement of Comprehensive Revenue and Expenses when:

- A) year end revaluation date; or
- B) at the time the share or bond trade occurs.

j Changes in accounting policy

Except as noted below, accounting policies have been applied on a consistent basis with those of the previous reporting period.

A) Cash and Cash Equivalents

During the year, the Group changed its accounting policy by removing cash held in investment portfolios from the definition of cash and cash equivalents. The change was made because cash held in investment portfolios is for investment purposes rather than meeting the Group's short-term cash commitments.

The Group initially recognises financial instruments when the Group becomes a party to the contractual provisions of the instrument.

The Group derecognises a financial asset when the contractual rights to the cash flows from the asset expire, or it transfers the rights to receive the contractual cash flows in a transaction in which substantially all the risks and rewards of ownership of the financial asset are transferred. Any interest in transferred financial assets that is created or retained by the Group is recognised as a separate asset or liability.

The Group derecognises a financial liability when its contractual obligations are discharged, cancelled, or expire. The Group also derecognises financial assets and financial liabilities when there has been significant changes to the terms and/or the amount of contractual payments to be received/paid.

Financial assets and liabilities are offset and the net amount presented in the Consolidated Statement of Financial Position when, and only when, the Group has a legal right to offset the amounts and intends either to settle on a net basis or to realise the asset and settle the liability simultaneously.

The Group classifies financial assets into the following categories:

Financial assets Classification and subsequent measurement

On initial recognition, a financial asset is classified as measured at: amortised cost, or fair value through other comprehensive revenue and expense (FVOCRE); or fair value through surplus or deficit (FVTSD).

A financial asset is measured at amortised cost if it meets both of the following conditions and is not designated as at FVTSD:

- i. it is held within a management model whose objective is to hold assets to collect contractual cash flows; and
- ii. its contractual terms give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

All financial assets not classified as measured at amortised cost as described above are measured at FVTSD. This includes the investment portfolios (see Note 7).

6. Financial instruments (continued)

Financial assets - Management model assessment

The Group makes an assessment of the objective of the management model in which a financial asset is held at a portfolio level because this best reflects the way the business is managed, and information is provided to management.

The information considered includes:

- i. the stated policies and objectives of the portfolio.
- ii. how the performance of the portfolio is evaluated and reported to the Group's management.
- iii. the risks that affect the performance of the management model (and the financial assets held within that management model) and how those risks are managed; and
- iv. the frequency, volume and timing of sales of financial assets in prior periods, the reasons for such sales and expectations about future sales activity.

Financial assets that are held for trading or are managed and whose performance is evaluated on a fair value basis are measured at FVTSD.

Financial assets – Subsequent measurement and gains and losses

Financial assets at FVSD - These assets are subsequently measured at fair value. Net gains and losses, including any interest or dividend income, are recognised in surplus or deficit.

Financial assets at amortised cost - These assets are subsequently measured at amortised cost using the effective interest method. The amortised cost is reduced by impairment losses. Interest income, foreign exchange gains and losses and impairment are recognised in surplus or deficit. Any gain or loss on derecognition is recognised in surplus or deficit.

6. Financial instruments (continued)

Financial liabilities - Classification, subsequent measurement and gains and losses

Financial liabilities are classified as measured at amortised cost or FVTSD. A financial liability is classified as at FVTSD if it is classified as held-for-trading, it is a derivative or it is designated as such on initial recognition. The Group classifies all its financial liabilities at amortised cost. These financial liabilities are subsequently measured at amortised cost using the effective interest method. Interest expense and foreign exchange gains and losses are recognised in surplus or deficit. Any gain or loss on derecognition is also recognised in surplus of deficit.

Impairment of non-derivative financial assets

The Group recognises loss allowances for expected credit losses (ECLs) on financial assets measured at amortised cost.

The Group measures loss allowances at an amount equal to lifetime ECLs, except for the following, which are measured at 12-month ECLs:

- i. bonds and term deposits that are determined to have low credit risk at the reporting date; and
- ii. other bonds and term deposits and bank balances for which credit risk (i.e., the risk of default occurring over the expected life of the financial instrument) has not increased significantly since initial recognition.

The Group considers bonds and term deposits to have low credit risk when its credit risk rating is equivalent to the globally understood definition of 'investment grade'.

Credit-impaired financial assets

At each reporting date, the Group assesses whether financial assets carried at amortised cost are credit-impaired. A financial asset is 'credit-impaired' when one or more events that have a detrimental impact on the estimated future cash flows of the financial asset have occurred. Loss allowances for financial assets measured at amortised cost are deducted from the gross carrying amount of the assets. The gross carrying amount of a financial asset is written off when the Group has no reasonable expectations of recovering a financial asset in its entirety or a portion thereof.

The Trustees conclude that there has been no change in fair value of 311 Hawthorne Drive in the current year (2023: \$350,000) based on rental income, current leasing arrangements and available market data at balance date. The investment property has not been valued by an independent valuer this year or in the prior year.

48 Grant Road, Frankton, Queenstown (NZ Couriers Building)

As at 31 March 2024, it has been determined by the Trustees that the current capitalisation rate of 4.28% (based on actual rent) is at market value, and therefore at fair value, and the valuation within the consolidated financial statements of \$7,450,000 is the market value for 48 Grant Road as at 31 March 2024 (2023: \$7,450,000).

The Trustees conclude that there has been no change in fair value of 48 Grant Road in the current year (2023: \$nil) based on rental income, current leasing arrangements and available market data at balance date. The investment property has not been valued by an independent valuer this year or in the prior year.

i) Recognition and Measurement

Investment property is initially measured at cost. Cost includes expenditure that is directly attributable to the acquisition of the investment property. Investment properties are subsequently measured at fair value.
